


#### **Exclusion area.**


The exclusion area is the space around the logo which must remain free from other elements to ensure that the logo is not obscured.















#### Minimum size.

This is the minimum size the logo should have for printing purposes and for the web. Never change the proportions when resizing it.

Print: 1 cm width

#### Placement on different backgrounds I.

Use the gradient logo over images and colored backgrounds always with a white circle underneath. When placing over white background the white circle is not necessary. Some examples:





#### Placement on different backgrounds II.

The monochrome version logo is ideal for use over images and colored backgrounds. When placing over photography, ensure contrast by placing the logo in bright color over dark area or the logo in dark color over bright area. Some examples:

## Information on EU funding.

#### Obligation and right to use the EU emblem
